Suppliers of Sinyi Group, the signatory party, should abide by the government laws and regulations and the norms of this code of conduct.

The signatory party may not:

- 1. Overtly or covertly bribe staff of Sinyi Group, nor reimburse staff for expenses that should be paid by the individual;
- 2. Offer gifts (of items or of money), or any form of negotiable securities or other payment vouchers to Sinyi Group staff;
- 3. Provide any form of consumer entertainment to Sinyi Group staff;
- 4. Facilitate the shareholding, equity participation, part-time employment, or other personal profits of Sinyi Group staff with the signatory party. Make use of relationships with the signatory party through formal duties to borrow from said party, or to invest with said party, not through open transaction:
- 5. Use formal relationships with staff of Sinyi Group to introduce said staff's relatives or friends to work for the signatory party;
- 6. Engage in other improper behaviors which may impact normal business operations.

In order to comply with relevant spirit of sustainability, the signatory party:

- 1. Should not have any major negative impact on the environment or violate environmental regulations during daily operations.
- 2. Should establish environmental protection and energy saving policies and measurements, and commit to protect the earth and resources.

- 3. Should not have any major negative impact on the environment/communities where it operates, and should establish friendly relationships with local communities, and try its best to help local development in education, economy, and culture, etc.
- 4. Should protect the health, safety, and privacy of consumers while offering services.
- 5. Should abide by labor laws to protect the safety and legal rights of its employees. Taking international human rights policy into account, such as prohibiting child labor, eliminating any form of forced labor, and not jeopardizing basic labor rights.
- 6. Should provide a fair working environment, to safeguard the fairness of the recruitment policies. Employees of the signatory party are fully protected against any discrimination, harassment or unfair treatment for reasons of gender, race, age, marital status, nationality, religion, etc. And equality of remuneration, hiring conditions, training, and promotion opportunities should be implemented.
- 7. Should provide employees with appropriate workplace health and safety training.
- 8. Should provide clean drinking water at workplace, and should maintain the hygiene of meals and dormitories if also offered.
- 9. Should implement corporate governance, and comply with the latest laws and regulations on human rights and environmental protection.

In order to uphold the anti-corruption policy and strengthen the awareness of ethical procurement, additional policy is formed for Sinyi Group employees.
